Superior Court of California, County of San Bernardino Appointed Services Fee Schedule Investigators, Legal Runners, Paralegals and Experts



The following is a summary of the Superior Court's rules and procedures pertaining to appointed services of investigators, legal runners, paralegals and experts from the Superior Court's Penal Code 987.2 Rules & Procedures. ESTABLISHING A VENDOR CODE

Appointed investigator, legal runner, paralegal, and expert services are paid by the County of San Bernardino. To establish a vendor code, the County requires a current W-9 form, available at www.irs.gov. To reduce payment processing time, you may attach the W-9 form to your first claim.

COURT APPOINTMENT

Specific prior Court approval is required for all services, including transcription services [LRC 1418.1, 1419.3]. Costs of services performed prior to the order of the Court, and costs of services beyond that provided for in the court order, will be denied. [LRC 1418.1]

SCOPE OF WORK (BILLABLE ACTIVITIES)

Investigators Appointed by the Court: Includes actual investigative work and related activities, such as testifying. Investigator services shall **not** include activities that would normally be performed by attorney/staff, or in propria persona (pro per) defendant, such as sorting and redacting discovery; indexing discovery notebooks; ordering duplicates of photographs and tapes; preparing subpoenas and court orders; and photocopying and transporting or mailing materials, motions, orders and clothing.

Attendance at court will not be reimbursed unless the investigator is testifying or otherwise sufficiently justifies the appearance, such as delivering exhibits, etc. Extraordinary amounts of time conferring with defense counsel or in propria persona (pro per) defendant will not be reimbursed unless it involves the investigator's direct services and must be justified in the billing statement.

Investigators Appointed upon Request of in Propria Persona (pro per) Defendants: Redacting discovery; mailing legal material, motions and orders to and on behalf of the defendant. Hand-delivery of material will be at the Court's Appointed Services Fee Schedule rate for appointed legal runners in the absence of extenuating circumstances. Determination of extenuating circumstances will be at the discretion of the Superior Court's PC987.2 Judge.

Legal Runners: Photocopying and transporting materials, orders and motions. Visitations and phone calls to the detention centers must be associated with an allowable billable activity, and will be subject to the discretion of the Court. Appearances in court are not an approved activity.

Paralegals: Must work under the direction and supervision of a member of the State Bar [B & P 6450].

EXTRAORDINARY EXPERT FEES

Requests for extraordinary expert billing rates that exceed those specified in this fee schedule must be submitted in compliance with the Court's PC987.2 Rule and Procedures.

It is the duty of counsel to endeavor to negotiate the lowest hourly rate the expert will work for recognizing that the expert's services are a public expense. [LRC 1419.6]

If extraordinary fees are authorized, billings must provide sufficient specificity with regard to services performed to support the bill for payment, with dates and times of service itemized.

CLAIM (PAYMENT) PROCESS

Court-appointees shall request payment using **claim form 17713 Appointed Investigator/Expert Service Claim Form,** available on the Court website, at https://www.sb-court.org/forms-and-rules/appointed-services-and-claim-forms

All claims shall be fully itemized as to specific dates, hours, activities, case name, case number and date of appointment and primary charge. The minimum billing increment is .25 hours (15 minutes).

Appointed service claim forms are to be either dropped off or mailed to the Court Verifying Official at the courthouse where the case is assigned. A file stamped copy of the court order of appointment must accompany all claims for payment. Costs of services performed prior to the order of the Court, and costs of services beyond that provided for in the court order, will be denied.

Original receipts required for all expense items. Special expense items and any single expense items in excess of \$50 must have specific prior court approval to be reimbursed.

MILEAGE

Mileage is paid at the current Court approved rate. When claiming travel time or mileage reimbursement, locations (city) must be specified.

Investigators will not be reimbursed for travel time or mileage more than 30 minutes or 20 miles outside of San Bernardino County. If the investigator is required, due to the nature of the case, to travel outside San Bernardino County, the defendant must obtain the written authorization of the Superior Court's designated PC987.2 judge prior to the travel before the investigator may be reimbursed for that travel time or mileage.

CLAIM DEADLINES

All claims shall be submitted within 60 days of completion of case, and must specify services performed to support the bill for payment, with dates and service hours itemized.

LEGAL RUNNER SCREENING AND RESTRICTIONS

Appointed legal runners are subject to an application process and background check conducted by the San Bernardino County Sheriff's Department. Legal Runners must have government issued photo identification, such as a California Driver's License.

Applicants who meet the following conditions are a security risk and will be denied:

- Felony convictions
- Excessive Misdemeanor convictions
- Jail or prison within the last 6 months
- Drug addict
- Registered per HS11590
